

## **2010 ANNUAL REPORT**

"UNPA is an amazing resource. As a first time homebuyer and single young professional, I had very specific needs and question --- where to look for quality properties, how to assess the value of the block I was buying into, and how to find a place that combined affordability, safety and neighborliness. Despite dismal real estate news, there continues to be a demand for housing in this Neighborhood. As a result, of the 34 buyers who participated in the FY2009-2010 **University Neighborhood Homebuyers Assistance Program**:

- 78% maintained owner-occupancy by purchasing move-in condition properties
- 79% are first time homebuyers
- 45% are SU/College of Forestry faculty and/or staff
- 100% work in the City of Syracuse

For the past 17 years, UNPA has assisted more than 700 homebuyers with over \$3 million in grants; and more than 300 homebuyers with over \$750,000 in grants and loans within the last 5 years alone.

The **University Neighborhood Home Improvement Loan** continues to be a successful program. Launched in 2006, Round I originated from efforts of former Congressman Walsh to secure funding for the Syracuse Neighborhood Initiative (SNI). In that round, UNPA, Home Headquarters (HHQ) and the City pooled their respective funding sources to create a low-interest home improvement loan fund that was marketed exclusively to owner-occupants within the Service Area. UNPA served as lead applicant and HHQ as co-applicant for that SNI Grant application. HHQ calls this home improvement loan program ... " one of the most popular and successful loan programs we administer".

- In Round I, using \$45,000 in SNI funds, UNPA bought-down a 6.99% interest HHQ Flex Fund Loan to 1.99%. Loans totaling \$300,000 for 22 cases were distributed in a record-breaking 2 1/2 weeks. As a result, the Program garnered accolades from the Congressman and the City, and became a model from which other City neighborhoods learned how to leverage community development dollars.
- In Round II, UNPA used \$33,000 of our funds to buy-down a 6.99% interest Loan to 3.99% for 29 cases.
- In Round III, UNPA invested \$40,000 of our funds and \$30,000 in UNSAAC funds to buy-down a 7.99% interest Loan to 2.99% for 41 cases to date. Lending limits were increased \$10,000 to \$20,000 for eligible applicants.

In 2009, UNPA collaborated with HHQ (investing \$11,000 of our own funds) on the rehabilitation of **224 Fellows Avenue**. This tax-delinquent decaying, long-time single-family rental, a former "drug house", was slated for demolition in 2008. It is now owned and occupied by Jessie Daino, proprietor of Recess Coffee House.

In 2009, UNPA launched a new program, **Rescue a Rental: Make a House Your Home**, as further incentive to new homebuyers to assist in turning rental houses into owner-occupied homes within a South East University Neighborhood closest to the S.U. Campus. With this program, UNPA offers up to \$4,500 in homebuyer's assistance and a home improvement loan of up to \$20,000 at 2.99% interest for approved interior and exterior renovations. In 2010, UNPA added "rent to own" and "development" programs to the original *Rescue a Rental Concept*.

In 2010, UNPA is investing \$10,000 of our own funds to jump-start the **University Neighborhood Housing Plan**. The Center for Community Design & Research at SUNY-CESF has been contracted to facilitate development of the plan. The purpose of this undertaking is to supplement the draft City Housing Plan, and to determine where the UNPA Target Area should be with regards to owner-occupied housing in the future, and how to take to get there. These outcomes will be realized through the process of developing a vision statement, setting goals, and creating an action plan to achieve those goals with participation.
